AGREEMENT FOR MEMBERSHIP AND AIRCRAFT HIRE

In consideration of being accepted as a member of the ASC and thus being granted approval to enjoy the various facilities offered by the Club, I acknowledge the following:

1. I understand that the Committee may require me to undergo a medical examination by a qualified medical practitioner. This would only be required where there is concern that a medical condition may affect my ability to safely fly an ASC owned or operated aircraft.
2. I understand that making a false declaration in the application may revoke my membership of the ASC.
3. I agree to acquaint myself with the Constitution of the Club, its Guidelines and By-Laws.
4. I agree to comply with the requirements of the Club’s Constitution, its Guidelines and By-Laws.
5. Membership is automatically renewed on the 1st of November for the following 12 months. If you do not wish to continue your membership, please advise the Club in writing as soon as possible.
6. I understand that when reference is made to Club owned property the reference also applies to aircraft cross hired by the Club. In particular, in relation to aircraft damage, I acknowledge the below mentioned Clauses 73 and 75 of the Constitution and agree to abide by them.

Clause 73. The Club shall not be responsible for any injury or damage sustained by members of the Club hiring or using aircraft for solo, passenger, instructional or other flights, nor for damage or injury to members or their property while on the aerodrome nor for damage or injury to third parties nor for any damage or injury to the person or property of any person flying in Club machines or being on Club’s premises or aerodrome.

Every member of the Club using any aircraft belonging to the Club or using or operating any of the Club’s equipment hereby agrees to indemnify and save harmless the Club against any action that may be brought against the Club by reason of or as a result of such use.

Clause 75. It is condition of becoming a member of the Club that every member of the Club causing loss or damage to the Club or to the equipment or property of the Club shall be required to reimburse the Club for any monies expended by the Club in repairs or replacement of Club property made necessary by such damage.

For Full Flying members, the extent of the reimbursement is to be the amount of the insurance excess or the actual cost of the repairs or replacement (whichever is the lesser amount), except that the Committee when considering any report or submission in relation to the incident causing the loss or damage may reduce the amount of the reimbursement.

For Non-Members and Short-Term Members, it is a mandatory requirement that the extent of the reimbursement is to be the amount of the insurance excess or the actual cost of the repairs or replacement (whichever is the lesser amount).
